Enable provides dozens of services (see back panel) none of which would be possible without our dedicated staff. In 2003 Enable enhanced orientation, training, professional development and recognition programs. I would like to take this opportunity to thank all the Enable employees and volunteers who made the successes of 2003 possible.

Enable experienced modest growth in all departments, with an aggregate increase of 11% over 2002. We initiated some internal management changes by adding a member to the senior management team, strengthening the Human Resource department and outsourcing Clinic billing. The agency implemented a formal Corporate Compliance program inclusive of the new federal HIPAA regulations.

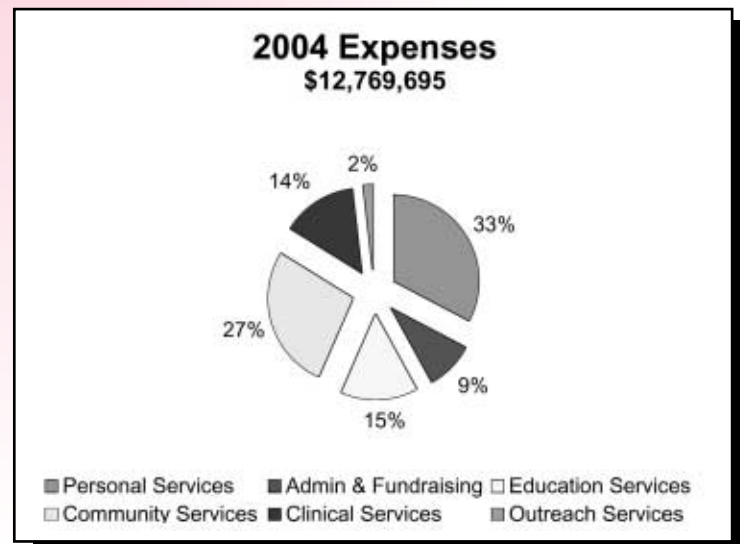
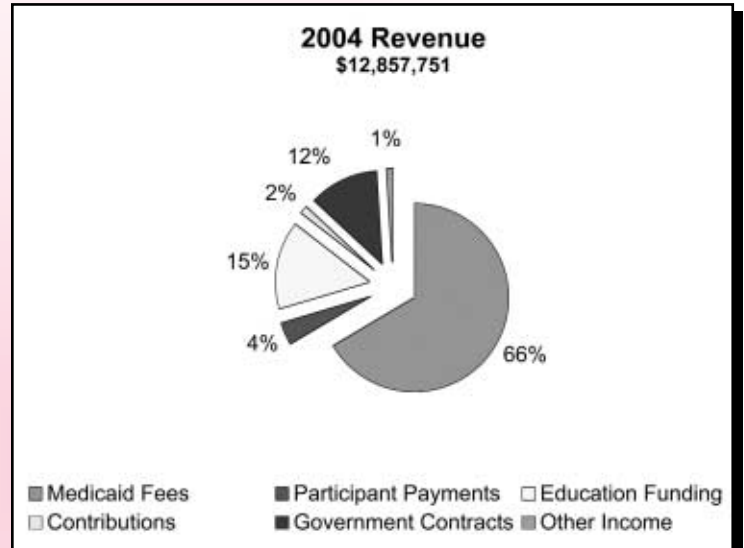
Highlights of 2003 include the Shining Lights Awards Celebration at the Welch Allyn Lodge and the Clare L. Smith Golf Classic with Jim Boeheim auctioning Championship S.U. basketball memorabilia.

Individual Living Services celebrated ten years of service with people who would previously have been served in group living arrangements, but now live independently. Community Networks' participants displayed talent in several music and art activities. Community Art #9 won the People's Choice Award and the Whatevah Samba group cut a CD. Enable celebrated the fifth year of operation of the Thomas Drive IRA, which has never received a negative evaluation from the OMRDD Bureau of Program Certification.

Education Services launched a "mentoring" program for professional development and a "family literacy" program with support from the employees of New Process Gear.

Comprehensive Clinical Services expanded upon the successful STARS groups to introduce a summer day camp component for children with Asperger's Syndrome. Outreach Services in Oswego County were strengthened with support from United Way.

Enable provided services to 2,066 children and adults with disabilities in 2003. The agency provides assessment, instruction, therapy and support for individuals with developmental, physical and health related disabilities. Thanks to the support of our participants and their families, Enable is one of the largest human service agencies in Central New York.



New Scanner Technology

Thanks to the support of hundreds of people, Enable raised over \$16,200 as our share of the \$200,859 raised by the Syracuse Auto Dealers Charity Preview. The event supports Project Adapt, our regional lending library for adapted toys and equipment. The funds will be used to purchase a scanner and bar code device so that the service will work just like a public library. This is the first step toward members being able to reserve equipment on line.
