## 2005 Annual Report

Enable provided services for 1,961 people in 2005, 83% of whom reside in Onondaga County. The impact of Enable services reached hundreds of additional people who are family members, teachers, co-workers or caregivers of the identified participants.

Of \$14,405,783 in revenue recognized in 2005, 65% was received as fees from Medicaid, 26% was payment on government contracts, 7% was fees from insurance and other sources, and 2% was derived from contributions and fund raising. The agency expended \$14,138,746. Enable employed 784 different people in 2005; 216 worked full

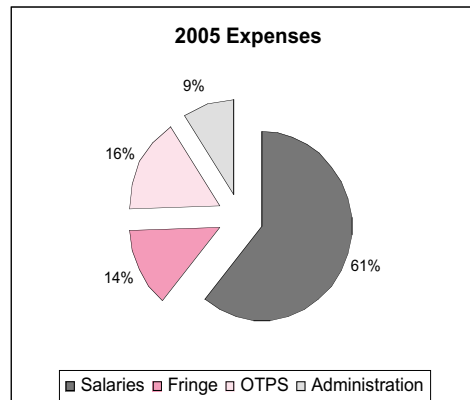
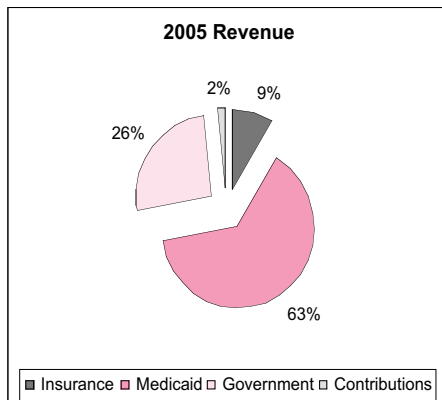

time and 577 worked part-time. The total hours worked calculates to 375 full time equivalents. There were no changes in agency management during 2005.

Highlights of the year include the opening of a new residence for four people in Camillus and development of the "young adult program" to support people with developmental disabilities moving into their own apartments for the first time.

Enable discontinued Computer Training as well as therapy services at the Westcott Street clinic location. For most of the year, the new building at Court Street was under construction.
